


FUNDING – PART B Implement Action Plan

- Up to \$24m over a period of up to 48 months
- Coordinate and implement the Action Plan with Spotlight partners
- Responsible Entity forms sub-contracts or other agreements with Spotlight partner organisations
- Funding instalments subject to satisfactory Progress reports

Consult	Consult widely and give all stakeholders a voice
Review	Review and consider best practice from around the world and in WA
Plan	Consider all aspects of RHD and what we need to do to effect change
Draft	Draft a 4-year plan for research, innovation and translation activities
Partner	Identify all relevant partners to deliver the research, innovation and translation activities
Consult	Seek sector-wide review of the draft plan
Finalise	Present draft plan

Application

- The Spotlight Coordinating Teams suitability to lead the activity
- Your plan for consultation and collaboration
- Your plan for developing a comprehensive, sector-driven Action Plan to address all aspects of RHD
- Your plan for forming and managing partners
- Your plan for streams of research and innovation
- Consideration of cash and in-kind contributions
- Due 11 March 2026

If Application successful

- Up to \$1 million available over 9 months
- Form partnerships and develop a comprehensive Action Plan
- The Action Plan must:
 - set out the research and innovation activities to be delivered through Spotlight partners
 - include the plan for distribution of funds to partners



Budget requests — Part A

Can include:

- Partners' budget requirements
- Consumer and community involvement requirements
- Salary for the Spotlight Coordinating Team and Activity Lead (no duplication, up to 1.0 FTE)
- Essential services and supplies
- Travel that is essential to the activity
- Equipment that is unique to the activity
- Specialised computing requirements unique to the activity



FTE commitment should be adequate to coordinate the activities for Part A activities



Team members are those who are involved in implementing Part A activities – does not need to be partners you may need in Part B (as this is yet to be determined)



Can include project managers or operational staff (not expected to all be researchers or innovators)



The number of members should be determined by the mix of skills, relevance, experience, track record of members ensuring suitability to collectively lead and manage large-scale initiatives

Establish strong program governance

Oversee and manage program over 4 years and ensure delivery on agreed Action Plan

Distribute funding to partners delivering activities

Attract co-investment from other sources

Apply for other funding sources to further promising areas of work

Coordinate whole of sector activities to share learning
